



**PRODUCE FOR KIDS® & VILLAGE FARMS HOLIDAY SWEEPSTAKES  
OFFICIAL RULES**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **Entry Period.** The Produce for Kids & Village Farms Holiday Sweepstakes (“Sweepstakes”) begins December 6, 2017 at 12:01am EST (“Start Date”) and ends December 31, 2017 at 11:59pm EST (“Sweepstakes Period”). This Sweepstakes is void where prohibited or restricted by law.
2. **Eligibility.** The Sweepstakes is open to individual legal residents of the 50 United States and the District of Columbia, age 18 or older as of the Start Date. Produce for Kids and its subsidiaries, affiliates, sales representatives, and any other parties associated with the development and execution of this Sweepstakes (and their immediate families and members of the same household) may not participate in this Sweepstakes.

4. **Selection of Winners.** Three (3) winners, a 3<sup>rd</sup> place, 2<sup>nd</sup> place and grand prize winner, will be selected from among all eligible entries received in a random drawing (“Drawing”). The Drawing will occur on or about January 2, 2018. The winners will be notified on or about January 3, 2018 by email at the email address provided upon entry.
5. **Prizes and Odds.** One (1) grand prize winner will receive one (1) gift basket of Village Farms tomatoes (estimated retail value of grand prize: \$100, provided by Village Farms). One (1) second prize winner will receive one (1) PlanetBox stainless steel lunchbox (estimated retail value of grand prize: \$56, provided by Village Farms). One (1) third prize winner will receive one (1) Village Farms apron (estimated retail value of grand prize: \$20, provided by Village Farms).
